
Murals | Illustration | Chalk Art

Chloe learned much about painting just by doing it! She started out painting murals in her room and her friends rooms. She studied at RIT and received a BFA in Illustration and at the University of Georgia (UGA) on a Study Abroad Program in Cortona, Italy. When discussing murals, Chloe stated, "They are a lot of work!" She recently painted the mural in the connecting tunnel in the Rochester Central library. The Grand Opening was this Oct. 17th. Chloe has many murals around Monroe County. You can find a list of her work on her website.



As for techniques, she shared the following: sketch out your design and then transfer to a grid. Many murals take over 100 hours and over a month to complete. She does both exterior and interior murals, such as in the Monte Alban restaurants around town. She painted acrylic on canvas that is then stapled on to the wall in the restaurant. As for exterior murals, in Canandaigua, there is a jewelry store at Coach and Main street with her mural on the wall. She painted on polytab (also can use parachute cloth) first in her studio and then used gel medium to stick the mural to the exterior wall and varnished to protect. Prepping the wall first is very important to create a smooth surface: clean the surface with soapy water for mild cleaning or use TSP or Borax mixed with water. Sand then prime and allow to dry for 24 hours. Masonry or other bumpy surfaces are very hard on brushes. You should only paint when temperatures are above 60F since paint will not bond to the surface. Sidewalks are painted using exterior paint with concrete sealer. She also paints acrylic murals and images on old furniture.

Chloe provided this tip to help scale from your grid to a large wall - use a proportion wheel. (http://www.herbfogler.com/proportionater.html) She uses an Isolation coat after painting a mural and then applies Golden brand acrylic varnish using x-marks with brush or roller. Another tip - If you mix acrylic paint with unsanded grout to make a mural, it can also serve as a chalkboard!


















REMINDERS
